**RIDER 25  
ELECTRIC SPACE HEATING**

**Applicable to Rates 6, 6L, 24 and 87**

**AVAILABILITY.**

This rider is available to any customer using the Company's electric service, through electric space heating facilities or a combination of such facilities and solar energy collectors providing space heating through heat exchangers, to provide all of the space heating requirements of his premises or any part of his premises which is sufficiently separated from the remainder so that there will be no material heat transfer between such part and the remainder. In no event will this rider be available for heating supplementary to that provided by other means.

**\* CHARGES.**

**Heating with Light.**

This service is available to only those customers to whom the Heating with Light provisions were applied for billing purposes as of the effective date shown below. The electricity supplied for such lighting shall be deemed to have been supplied for space heating.

Charge per kilowatt-hour for kilowatt-hours supplied in the month:

**Summer Months**

For the first 30,000 kilowatt-hours .....7.146¢  
For all over 30,000 kilowatt-hours.....6.891¢

**All Other Months**

For the first 30,000 kilowatt-hours .....6.568¢  
For all over 30,000 kilowatt-hours.....6.331¢

No demand charge shall apply.

**Space Heating – Other than Heating with Light.**

Subject to the provisions set forth below, the charge for electric service supplied for space heating under this rider during the Non-Summer Months shall be the lower of:

(a) the following charge per kilowatt-hour:.....4.557¢

or

(b) the charges, under the customer's rate, for adding such service to the service otherwise supplied to the customer, except that such charge shall apply only to electricity supplied to facilities used exclusively for space heating or for a combination of space heating and cooling.

**CHARGES. (CONTINUED)**

**Summer Months.**

For the purposes hereof the Summer Months shall be the customer's first monthly billing period with an ending meter reading date on or after June 15 and the three succeeding monthly billing periods. Non-Summer Months shall be all other monthly billing periods.

**Late Payment Charge.**

The late payment charge provided for in the Terms and Conditions of this Schedule of Rates shall be applicable to all charges under this rate.

**COMBINED HEATING AND COOLING FACILITIES.**

If the customer uses the Company's electric service for both space heating and cooling and such service is provided through common metering facilities, all of the electricity supplied for such purposes during non-summer months shall be deemed to be supplied for space heating.

**WIRING REQUIREMENTS.**

The wiring for all facilities to which electricity is supplied under the provisions of this Rider shall be arranged so as to permit separate measurement of the additional demands and energy use of such facilities if the charging provisions of this Rider are to apply.

**GENERAL.**

- \* For the purposes of this Rider a customer qualifying for Heating with Light service may elect to treat as service for lighting, service for water heating and service to any auxiliary facilities used exclusively for heating. Any space heating customer (other than a heating-with-light customer) who, under prior provisions of this rider, had elected to treat water heating service in the same way as space heating service may continue to do so. The Company may at its option, however, terminate such treatment of water heating service by rearranging, at its expense, the customer's wiring and metering. In the case of a building transferring to this Rider which utilizes a common boiler system in existence prior to October 14, 1977, to provide all of the space heating and water heating requirements of the building, if it is impracticable to separate such water heating from the space heating, the electricity supplied for such boiler system shall be deemed to have been supplied for space heating.
- \* Notwithstanding anything to the contrary in the rate schedule of which this Rider is a part, a customer may receive service hereunder for all of the space heating requirements of his tenants in a multi-occupancy building, and, if the customer qualifies for Heating with Light service, may receive service for such lighting in tenant-occupied spaces under the heating with light provisions above.

Except as specified above, all other provisions of the rate shall apply.
